This Customer Privacy Statement outlines the policy of Managed Data Solutions, LLC ("MDS") and how we will treat any information gathered or provided to MDS in the course of our computer support, network support or any other consulting services for you the customer ("Customer").

1. Customer desires to engage MDS to provide computer support, network support or other consulting services and MDS desires to provide said services, both parties understand and agree that MDS will have access to all information as required by MDS to complete the services tasks to be provided.

MDS may report any activity that it suspects violates any law or regulation to appropriate law enforcement officials, regulators, or other appropriate third parties. To the extent any inconsistency exists between any terms of this Privacy Statement and MDS's right to disclose under this section, MDS's right to disclose under this section will control.
5. Customer represents and warrants that he/she has full authority to enter into this agreement and is at least 18 years of age. Customer further represents it is not located in or associated with any country subject to United States embargoes or listed on the United States Treasury Departments list of specially designated nationals or listed on the United States Commerce Department denied persons list or entities list.
